**GENERAL EXPLANATIONS**

1. Under the Personal Data Protection Law no. 6698 ("**Law**") the personal data owners are defined as a relevant person ("**Applicant**"), and under Article 11 of the Law, the data controllers were granted the right to direct certain requests regarding the processing of personal data.
2. Version Tekstil Turizm Sanayi ve Dış Ticaret A.Ş. is considered as the data controller under the first paragraph of Article 13 of the Law. Any application made to ("**VERSION**") regarding these rights must be submitted in writing.
3. In this context, any application to VERSION must be made in "written" form then those applications might be delivered by:
  - Delivering the wet signed copy in person or through a notary public to "*Yahya Kemal Beyathı Cad. No: 16 BEGOS Buca / İzmir*" address via mail or
  - By signing with the "secure electronic signature" of the applicant as defined in the Electronic Signature Law No. 5070, and sending to [versiontekstil@hs02.kep.trorinfo@versiontexas.com](mailto:versiontekstil@hs02.kep.trorinfo@versiontexas.com) addresses.
4. If another application method is determined and announced by the Board, the announcements regarding these methods shall be declared on the website of VERSION.
5. Depending on the nature of the request, your applications submitted to VERSION will be answered in accordance with paragraph 2 of Article 13 of the Law, within 30 (thirty) days from the date your request is received by VERSION. The answers given by VERSION will also be delivered to you in written or electronic media in accordance with Article 13 of the Law.
6. If your application requires an additional cost, you may have to pay a fee determined by the Communiqué on Application Procedures and Principles to the Data Officer issued by the Personal Data Protection Board. If your application is answered in writing, no fee shall be charged for the first 10 (ten) pages, after that, a transaction fee of 1 TRY will be charged for each page above 10 (ten) pages. If the answer to your application is given in a recording medium such as CD or flash memory, you shall be charged with the cost of the recording medium.
7. VERSION reserves the right to amend the Board's decision regarding the application procedures or the legal regulations to be issued in the future.
